Resolutions Organizational Meeting Tuesday, March 27, 2012

#### RESOLUTION No. 1 — Oppose CATS Tax

WHEREAS the Capital Area Transit System (CATS) has proposed a 10.6 mill property tax, which will be voted on in the City of Baton Rouge, City of Baker, and City of Zachary on April 21, 2012; and

WHEREAS the tax would require property owners to pay more than \$184 million over a 10-year period, when taxpayers are already overtaxed; and

WHEREAS the CATS Board purports to have the authority to waive the homestead exemption and require that the 10.6 mill tax be imposed without deducting the homestead exemption; and

WHEREAS CATS is a body politic of the State of Louisiana created by an act of the Louisiana Legislature in 2005 and is not municipality or a municipal district; and

WHEREAS the Louisiana Constitution provides that only municipal property taxes shall not be subject to the home-stead exemption; and

WHEREAS the wording of the CATS tax proposition is ambiguous and appears to levy 10.6 mills for operational expenses and 10.6 mills for capital construction, thereby creating the possibility of a 21.2 mill tax being imposed; and

WHEREAS ridership of CATS buses is very low and only two percent or less of the residents of the parish ride the bus; and

WHEREAS this tax would increase the annual budget of CATS from \$12 million a year to \$30 million a year, an excessive and completely unjustifiable increase; and

WHEREAS legislation is now pending in the regular session of the Louisiana Legislature, which would reduce the control over CATS by the elected members of the Metro Council.

THEREFORE, BE IT RESOLVED by the Republican Party of East Baton Rouge Parish that the party strongly opposes the proposed tax and urges all voters to oppose it on April 21, 2012, and further that the party shall conduct a campaign against the passage of said tax.

BE IT FURTHER RESOLVED that the Republican Party of East Baton Rouge Parish opposes the CATS legislation now pending in the Louisiana Legislature and urges members of the House and Senate to oppose this legislation.

BE IT FURTHER RESOLVED that the Republican Party of East Baton Rouge Parish reserves the right to take legal action to prevent the imposition of the CATS tax, insofar as it purports to waive the homestead exemption or levy more than 10.6 mills.

#### Resolutions Thursday, April 12, 2012

RESOLUTION No. 3 — Resolution on South Baton Rouge Community School Districts

WHEREAS legislation is being considered in the Louisiana Legislature to create one or more independent community school districts in the southern part of East Baton Rouge Parish; and

WHEREAS the creation of the Zachary and Central community school districts demonstrates that this approach can result in high quality public schools for all students; and

WHEREAS the boundaries of any such new community school districts are critical to their viability, especially considering the existence or absence of adequate school facilities within those districts.

THEREFORE, BE IT RESOLVED by the Republican Party of East Baton Rouge Parish that the party strongly supports the concept of creating one or more new community school districts in the southern part of East Baton Rouge Parish.

BE IT FURTHER RESOLVED that the Republican Party of East Baton Rouge Parish supports the creation of one large community school district encompassing much of South Baton Rouge, or the creation of two or three community school districts in South Baton Rouge.

BE IT FURTHER RESOLVED that the Republican Party of East Baton Rouge Parish believes that it is of utmost importance that existing school facilities in South Baton Rouge should be equitably shared among all new community school districts created and that no one new community school district should get an undue portion of school facilities or property in South Baton Rouge, so as to make the creation of other new community school districts unfeasible.

BE IT FURTHER RESOLVED that the Republican Party of East Baton Rouge Parish supports a constitutional amendment that would make it possible to create new community school districts in East Baton Rouge Parish by act of the legislature without the necessity of a further constitutional amendment.

RESOLUTION No. 4 — Resolution on Senator David Vitter

WHEREAS the Senate Ethics Committee in Washington considered a complaint filed against Sen. David Vitter because he withheld approval of a pay increase for the Secretary of the Interior; and

WHEREAS the Constitution provides that no Senator or Congressman can be appointed to a federal post if the salary of that post was increased during the Senator or Congressman's term of office; and

WHEREAS, a special law was passed by Congress to reduce the pay of the Secretary of the Interior specifically to allow a certain Senator to be appointed as Secretary of the Interior; and

WHEREAS, upon his appointment, the Secretary of the Interior refused to grant permits for offshore drilling in contravention of a federal court order; and

WHEREAS Senator David Vitter quite rightly used his power as a Senator to put a hold on a pay raise for the Secretary of the Interior until the Secretary of the Interior complied with federal law and federal court orders; and

WHEREAS the Senate Ethics Committee found that Sen. Vitter had violated no Senatel ethics rule but the committee chairman nevertheless criticized Sen. Vitter's action in holding up the pay increase for the Secretary of the Interior; and

WHEREAS the press ran stories with a confusing headline saying Sen. Vitter "Undid Trust," implying that the Senator had done something untrustworthy or wrong.

THEREFORE BE IT RESOLVED that the Republican Party of East Baton Rouge Parish finds that Sen. David Vitter's action were entirely proper and in accordance with federal law, federal court decisions, and the best interests of the people of Louisiana.

#### RESOLUTION No. 5 — Endorsement Process

WHEREAS the East Baton Rouge Republican Parish Executive Committee desires to provide information on Republican candidates to the registered voters of East Baton Rouge Parish and, where appropriate, to make recommendations or endorsements.

THEREFORE, BE IT RESOLVED that the Republican Party of East Baton Rouge Parish does hereby adopt the following Rules on the Endorsement Process:

## ENDORSEMENT PROCEDURE East Baton Rouge Republican Parish Executive Committee

#### A. Candidate Eligibility

- 1. In order to be eligible for an endorsement from the Republican Party of East Baton Rouge Parish, the candidate must be a registered Republican upon qualifying.
- 2. Every Republican who offers himself as a candidate for public office, which will be voted on in East Baton Rouge Parish, shall receive an Endorsement Questionnaire from the East Baton Rouge Republican Parish Executive Committee.
- 3. The Endorsement Questionnaire, which shall be designed by the Endorsement Committee and approved by the PEC, shall include some questions which are appropriate for all public offices and other questions which are appropriate for the particular office sought. The questionnaire may ask for other attachments, such as a formal resumé, letters of recommendation, proof of military service or graduation from institutions of higher learning, and other documentation.
- 4. The candidate shall attach to the returned Endorsement Questionnaire form, a certified proof of registration signed by their Registrar of Voters, indicating that the candidate is a resident of the district from which election is sought, and evidence that the candidate actually resides at that location and has resided there for the period of time required by law for that particular office.

#### B. Instructions to Candidates

A. The Endorsement Questionnaire shall be accompanied by a letter from the chairman advising the candidates of the procedure they must follow if they desire to be considered for endorsement by the party. The secretary, or a designated member, shall collect the Questionnaires and distribute copies of each Questionnaire to every member of the PEC.

#### C. Endorsement Meeting

- 1. The chairman shall determine when endorsement meetings are to be held for a particular election or for a particular public office. He may call such meetings before, during, or after the close of qualifying. Upon receipt by the secretary of a petititon signed by a majority of the PEC, the chairman shall call an endorsement meeting within seven days.
- 2. At a regular monthly meeting or a special called meeting, candidates will be given an opportunity to speak and answer questions from members of the PEC. <u>The meeting shall be open to the public and shall be conducted</u> with fairness to all of those seeking the endorsement.

#### D. Member Responsibility

- 1. A member who is a candidate for a particular office being considered for endorsement or who anticipates becoming a candidate for that office must recuse himself from voting on the Endorsement for the office he is seeking.
- 2. A member who has accepted monetary or other consideration from a candidate who is seeking an endorsement for a particular office must recuse himself from voting on the endorsement for that office.
- 3. A member who has already personally endorsed a candidate, donated to a candidate, or holds a position in the campaign of a candidate shall disclose that fact in writing to the chairman of the Endorsement Committee prior to the vote on endorsement for that office.

- 4. In a race with multiple Republican candidates, each member will have the option to cast a vote in favor of "Endorsement" or "No Endorsement" in a separate vote for each candidate.
- 5. In a race with a single Republican candidate, each member will have the option to cast a vote in favor of "Endorsement" or "No Endorsement".
- 6. No member may hold more than two proxies at an Endorsement meeting. A quorum, which is a majority of the total membership of the PEC, must be present in person or by proxy at all times in order to conduct business when candidates are speaking or answering questions.
- 7. Every member shall be allowed to ask two questions of each candidate, after which members may request permission from the chair for an additional question. At the conclusion of the questions, the candidate shall be given the right to close for a period determined by the chair. The members of the PEC shall then be allowed to discuss the candidate's qualifications and platform.
- 8. When matters of character or reputation come into issue, either the candidate or the chairman may request an executive session, which shall be voted upon by the PEC. If a majority of those voting in person and by proxy agree, the PEC shall meet in executive session solely for the purpose of discussing the matters of character or reputation. All such discussion shall be confidential, and no member of the PEC shall disclose this information outside the meeting. Any member who does reveal any such confidential matter shall be censured by the PEC and barred from participating in executive sessions for the balance of the term.
- 9. After all candidates in a race have been allowed to address the members, the members shall, by secret ballot, vote for the candidate(s) of their choice. A candidate must receive [a majority] [at least 60 percent] of the members present in person or by proxy to receive the Endorsement.
  - 10. "No Endorsement" shall be a Candidate in every race.
  - 11. There shall be no automatic endorsement of any incumbent.
  - 12. The secretary and two members designated by the Chairman shall count the votes.
  - 13. All vote totals shall remain secret by those charged with counting the votes.
- 14. The chairman and any member may meet with a candidate prior to an Endorsement meeting but neither the chairman nor any member shall make a commitment to a candidate that he will receive the endorsement of the party. The chairman may call a meeting of the Endorsement Committee to meet with a candidate or to discuss issues related to an endorsement. In such case, the committee shall report its findings or recommendations to the full PEC.

BE IT FURTHER RESOLVED that the Republican Party will continue to monitor this campaign and will meet again on Tuesday, October 24, or on another date of its choosing, to determine whether it would be advantageous to make further recommendations to Republican voters, such as the recommendation of a "unity candidate" who would best represent the Republican Party in the runoff election.
